ATTENTION EXHIBITORS: NO TRAINING allowed PRIOR to or DURING ratings. All entries must be paid at closing. Bitches in season allowed to run at end but must be kept away from test area until called. Notify test secretary. Dogs qualifying for a rating are awarded a ribbon and are recommended to WCA for approval and issuance of a certificate. Ratings are official when confirmed by the National Office.

ELIGIBILITY OF DOGS: Read Carefully

- a) Any Weimaraner with an individual AKC number or an ILP number who has obtained the age of 6 months on day of test for any or all ratings offered.
- b) Rating tests are open to all Weimaraners whose owners and co-owners are **members of the WCA**
- c) Spayed bitches/neutered males may compete.
- d) Weimaraners that have disqualifying faults (as listed in the current Standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. PRIOR to being entered in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. To receive a DQF Number owners must present a copy of the dog's AKC Registration Certificate or AKC recognized foreign registration certificate, and a copy of the dog's spay or neuter verification from their veterinarian to the WCA National Office.

The Greater Cincinnati Weimaraner Club assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children, whether, or not, they under the control of their parents and guardians.

Entries are limited to 8 hours of judging per judge. Following AKC regulations, entries automatically close when limits have been reached, even if this occurs before the official closing date. However, the club will maintain a waiting list up until the official closing date. If an entry is withdrawn prior to the official closing date and is replaced by a wait listed entry, the full entry fee for the withdrawn entry will be refunded.
